General Information

The Honolulu Century Ride is a family-oriented event in which participants ride at their own pace, following Oahu's eastern and windward shores. Riders start at and finish at Kapiolani Park, beginning at 6:15am.

Starting Order

The starting order is determined by riding style and ability, allowing riders of similar abilities to enjoy the ride safely.

Group A If your distance covered per month is over 311 miles (500km), average more than 19 MPH (30km), and you are used to riding in a group.

Group B If your distance covered per month is over 124 miles (200km) average more than 13 MPH (20km), and have experience participating in long rides.

Group C If you average 6 to 7 MPH (10-11 km) and your goal is to ride slowly while enjoying the scenery.

Group D For parents with children under 5 years of age.

Bicycle Helmets & Headphones

Bicycle helmets are mandatory and must be worn and properly fastened at all times. Headphones are not allowed while participating in the ride.

Photography

By participating in the ride, riders provide the Hawaii Bicycling League permission for free use of their name, voice, and picture in any advertising or promotion of the Hawaii Bicycling League's programs and events.

Team Iron Okole Competition

Form a team with at least five people. Each returning rider will check-in at the merchandise tent. The team with the most cumulative miles wins. Awards for first place will be available at the merchandise tent at 4:00pm. Visit www.hbl.org to download the form.

Route Closure Times

To participate in the 75 mile or 100 mile option you MUST leave the 50 mile turnaround by 11:30 am and the 75 mile turnaround by 10:30 am. Riders after these times will not be permitted beyond the aid stations.

**RELEASE and WAIVER of LIABILITY,
ASSUMPTION OF RISK, and INDEMNITY AGREEMENT**

In consideration for being permitted to participate in any way in Hawaii Bicycle League (“HBL”) sponsored Bicycling Activities (“Activity”), for myself, my personal representatives, assigns, heirs, and next of kin:

1. I acknowledge, agree, and represent that I understand the nature of Bicycling Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further acknowledge that the Activity will be conducted over public roads and facilities open to the public (including, without limitation, public and private vehicles) during the Activity and upon which the hazards of traveling are to be expected. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. I fully understand that: (a) bicycling activities involve risks and dangers of serious bodily injury to myself and others, including permanent disability, paralysis and death (“Risks”); (b) these Risks and dangers may be caused by my own actions or inactions, by the actions or inactions of others participating in the Activity, by the actions or inactions of others who are not participating in the Activity (including, without limitation, vehicle operators), the course and the conditions in which the Activity takes place, or negligence (including gross negligence) of the “RELEASEES” (as defined below); and (c) there may be other risks and social and economic losses I may suffer (or that I may cause) that are either not known to me or not readily foreseeable at this time. I fully accept and assume all such risks and full responsibility for all losses, costs, and damages I suffer (or cause) as a result of my participation in the Activity or, in the event of participation by a minor, the participation of the minor in the Activity.

3. I hereby release, discharge and covenant not to sue (a) HBL and its administrators, directors, agents, officers, members, employees, and volunteers in the Activity, (b) other participants in the Activity, (c) other volunteers in the Activity, (d) any and all sponsors, promoters, organizers, and advertisers of the Activity (including, without limitation, individuals, organizations and entities that may register participants in the Activity, such as yourself) or provide volunteers for the Activity, and, if applicable, (e) owners, lessors, lessees and licensees of premises on which the Activity takes place, (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages caused or alleged to be caused in whole or in part by the negligence (including gross negligence) of one or more of the Releases or otherwise, including negligent rescue operations.

4. I further agree that if, despite this RELEASE and WAIVER of LIABILITY, ASSUMPTION of RISK and INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.

BY SIGNING BELOW, I ATTEST AND AGREE THAT I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND INTEND TO BE BOUND BY ITS TERMS. I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING THIS AGREEMENT. I REPRESENT THAT I HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND I INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW. I AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID FOR ANY REASONS, THE BALANCE OF THIS AGREEMENT, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT TO THE GREAT EXTENT ALLOWED BY LAW.
