# 2024 Hawai'i Active Transportation Candidate Survey









The <u>Hawai'i Bicycling League</u> (HBL), <u>Kauai Path</u>, <u>Maui Bicycling League</u> (MBL), and <u>People for Active Transportation Hawaii</u> (PATH) emailed candidates for election in Hawaii across eight contests including: State Senator, State Representative, County Councils statewide and Mayor in Hawai'i County and Honolulu. **Additional Complete Streets Comments**: I would continue my work from previous terms to participate in the MPO STIP, support funding for complete streets and educate the public about healthy and safe transportation. Additional Vision Zero Comments: In my former terms as a County Councilmember, I was the sole councilmember present at the first meeting of Vision Zero in Maui County. I worked with MPO Director Lauren Armstrong to support education and funding for Vision Zero, and will continue to support the program as the North South Collector Road (and other important road infrastructure projects) are developed. This program, especially with the data available about higher speeds resulting in more deaths, needs greater public education and commitment in the next few years. Also, I previously worked with Lt. Hankins of the MPD to lobby for a reduction in the State's allowable legal blood alcohol limit!

Additional Emission Reduction Comments: I am a big advocate for multimodal transportation and renewable fuel use to replace fossil fuels. The verdict and settlement agreement of the lawsuit is very exciting to me, and I look forward to meeting with the plaintiffs and the DOT to help support the agreement in Maui County. As a member of the board of directors of ICLEI USA (icleiusa.org), climate action is a top priority for me. Along with setting interim goals and advocating for the State's use of renewable energy at their Maui sites, it is important to encourage the young folks who brought the lawsuit forward to continue their leadership and even run for county or state office!

## **Personal Transportation Habits**

Frequency of Public Transportation Usage: No Usage

**Additional Comments About Public Transportation Use**: I do not use public transportation on Maui as the only option is the bus which does not have routes that align with my schedule; however, on Maui I have driven only 100% biodiesel vehicles since the year 2000, using only locally produced biodiesel!



Frequency of Active Transportation Usage: Several Times Per Month

**Additional Comments About Active Transportation**: I use a 100% Biodiesel powered diesel passenger car for transportation and recreation, unless walking to the beach or other close activities. The biodiesel is produced in Hawaii from used cooking oil and residual crop oil (sunflowers and macadamia nut oil grown in Hawaii). For exercise, I have a stationery bicycle; however, I look forward to purchasing a personal bike and using it for transportation in South Maui once the North South Collector Road is completed!
